Enclosed is a copy of the Judging Program for the GHPWCF Specialty on Friday, February 22 and Saturday, February 23, 2019. Please take a moment to verify your entry information. Directions and a map to the Sheraton North Houston are included below.

Move-in to the various areas of our show site will be as follows.

Thursday Evening:

- The reserved grooming and crating room (Salons A & B) will open at 7:00 pm.
- Vendor space will be available for set up beginning at 7:00 pm.
- Hospitality Gathering 7:00 pm (info available at check-in.)
- The Bathing Station will be available at 7:00 pm.
- All rooms will be locked on Thursday at 10:00 pm.

Friday:

- The reserved grooming and crating room (Salons A & B) will open at 6:00 am
- The Performance and Conformation Show Rings (Salons C, D & E) will open at 8:00 am
- All rooms will be locked on Friday 2 hours after the conclusion of judging.

Saturday:

- The reserved grooming and crating room (Salons A & B) will open at 6:00 am
- The Conformation Show Ring (Salons C, D & E) will open at 8:00 am

Judging will begin with the Puppy Sweeps in Salon C, D & E at 9 am on Friday morning, followed by Veteran Sweeps and Beginner Puppy. The PWCCA Spring Meeting will take place during lunch. You do not need to be a member to attend. Conformation classes will begin at 1:00 pm. Judging on Saturday will begin at 9:00 am with our Performance Competitions, followed by Conformation classes at 12:00 noon. Pre-ordered boxed lunches will be available for pick up at noon on Friday and at 11:00 am on Saturday.

Un-reserved crating space is available on a *first come, first served* basis. Crating space may not be saved by roping off, using empty crates, chairs, or other equipment to hold space. Absolutely no exercise pens or drop pens will be allowed inside the show site. Bathing and grooming is NOT allowed in hotel rooms. A bathing station will be available. Please check with our show chair for details. Loading and unloading allowed in designated areas only.

From Sam Houston Tollway

- Exit at Beltway 8 East.
- Proceed on John F. Kennedy Boulevard North.

From Interstate 45 North/Hardy Toll Road / Highway 59 North

- Exit at Beltway 8 East.
- Proceed on John F. Kennedy Boulevard North
